## To: People interested in the Middle Entiat River Restoration Project

The Bonneville Power Administration (BPA), in cooperation with the Bureau of Reclamation (Reclamation), will be preparing an environmental assessment (EA) to analyze the effects of the proposed Middle Entiat River Restoration Project in Chelan County, Wash. This letter briefly explains what is being proposed, outlines our environmental review process and schedule, and requests your comments.

**Proposal:** BPA and Reclamation are proposing to fund multiple entities to restore habitat along a four-mile section of the Entiat River. The project would help re-establish natural riverine processes and improve the floodplain function to provide spawning, rearing, and off-channel refuge habitat for native fish—salmon, steelhead, bull trout, and other resident fish—and wildlife in the Entiat River basin.

Habitat improvements would include reconnecting historic side channels and strategic placement of varying sized log jams to help direct river flows into side channels and alcoves and onto the floodplain. Placement of logs would also increase the amount of wood in the river system, increasing habitat complexity.

**Environmental Review:** As the lead agency, BPA will prepare an EA following the procedures of the National Environmental Policy Act and Reclamation will serve as a cooperating agency. The EA will describe anticipated impacts to natural and human resources and include mitigation measures that would help avoid or minimize impacts. During this process, the agencies will work with landowners, federal, state and local agencies, interest groups, and Tribes.

The proposed schedule for the EA process is as follows:
