Please update the figures previously provided by BPA for Columbia River Spill mandated by the Federal court that are shown in the attached spreadsheet at this link: https://actuationtestequipment.com/Spill Data.xlsx."

- Data provided for previous FOIA request (BPA-2020-001159) for FY2020 was not an estimate but actual data.
- CRSO EIS spill change does not take place until FY2022, thus this past year FY2021 has the same spill operation as previous years. The number of spill plants in FY2021 was still eight.
