This business practice explains the criteria and requirements to complete a Resale of Point-to-Point (PTP) Transmission Service on the Open Access Same-Time Information System (OASIS).

A. General Criteria

1. Resales convey only transmission scheduling rights associated with PTP Transmission Service.
 - a. OATT Section 2.2 Renewal rights are not conveyed in a Resale.
 - b. OATT Section 17.7 Deferral rights are not conveyed in a Resale.
 - c. For transfers of all rights and obligations, see the Transfer of Transmission Service Business Practice.
2. The Reseller remains liable for the performance of all obligations under its Service Agreement.
3. ~~A Reseller cannot resell a reservation to itself.~~ The Reseller and the Assignee must ~~not~~ be ~~different~~ ~~the same~~ ~~Transmission~~ Customers.
 - ~~a. Multiple reservations from the same Transmission Customer may be aggregated into a single reservation using the Consolidation function on OASIS.~~
 - ~~i. See the Consolidation of Transmission Service Business Practice and Section G of the PTP TSR User Guide.~~

4. A Reseller may aggregate multiple Parent Reservations into a single aggregated Resale for reassignment on OASIS to another Customer.
- a. The PTP Transmission Service type (e.g., STF-MONTHLY PTP) must be the same for all Parent Reservations and the Resale TSR.
 - b. The Point of Receipt (POR) and Point of Delivery (POD) must be the same for all Parent Reservations and the Resale TSR.
 - c. If the Source and Sink fields are populated in any Parent Reservation, then they must be populated the same for all Parent Reservations and the resulting Resale TSR.
 - d. The conditional reservation deadline (Section 13.2 of the BPA OATT) of the aggregated Resale will be the latest conditional reservation deadline from the Parent Reservations.
 - e. None of the Parent Reservations may be designated under the Conditional Curtailment Option (CCO) outlined in the Conditional Firm Service (CFS) Business Practice.
- 4.5. All Resales must be posted on OASIS.
- a. See ~~Section 4~~ in the [PTP TSR User Guide](#) for Resale and TransAssign procedures.
- 5.6. Resales must include the price and the price unit entered must be in dollars per megawatt-hour (\$/MW-HOUR RESERVED). ~~Do not use the "Get Price" button, as it will not populate with the correct price unit.~~
- a. BPA does not set a price cap on Resales of PTP Transmission Service under Section 10, Attachment 1 of BPA's TC-20 Settlement Agreement.
- 6.7. BPA will not modify the Customer's Service Agreement to reflect Resales.
- 7.8. Should a ~~e~~Curtailment be necessary, the remaining portion, if any, of the Reseller's reservation and the Assignee's Resale reservation will be curtailed independently.
9. The criteria for handling Resales in the Preemption and ROFR process is outlined in the Preemption of Short-Term Transmission Service Business Practice, including specific obligations for Resellers.

B. Reseller Criteria

1. ~~A Reseller may post a Resale of any of t~~he following reservation service types are eligible for Resale:
 - 2.a. Long-Term Firm (LTF) PTP
 - a.i. LTF-YEARLY PTP
 - b.ii. LTF-CF7 PTP
 - 3.b. Short-Term Firm (STF) PTP
 - a.i. STF-Monthly PTP
 - b.ii. STF-Weekly PTP

~~e.iii.~~ STF-Daily PTP

~~4.c.~~ Hourly Firm PTP (F-HOURLY PTP)

~~5.d.~~ Short-Term Non-Firm (STN) PTP

~~a.i.~~ STN Monthly PTP

~~b.ii.~~ STN Weekly PTP

~~e.iii.~~ STN Daily PTP

~~6.e.~~ Hourly Non-Firm PTP

~~7.2.~~ A Reseller must enter the Resale on OASIS as ACCEPTED.

~~8.3.~~ The Sale Ref field must contain the Assignee's 5-digit Service Agreement number. For example, ~~a Customer (Assignee) with~~ a Service Agreement number of 21TX-11111 should be entered as report "11111." ~~in the Sale Ref field.~~

C. Assignee Criteria

1. The Assignee will verify the terms of the Resale are captured correctly, including that the Sale Ref field contains the correct 5-digit Service Agreement number for the Assignee.
 - a. If the Assignee agrees to the Resale, they shall set the Resale status on OASIS to CONFIRMED.
 - b. If the Assignee does not agree to the Resale or finds incorrect information, they shall either set the Resale status on OASIS to WITHDRAWN or contact the Reseller to have the Resale set to RETRACTED.
2. The Assignee will be subject to all terms and conditions of BPA's OATT, Rate Schedules, and business practices.
3. The Assignee may resell its scheduling rights through a subsequent Resale.
4. The Assignee may ~~r~~Redirect its scheduling rights through a subsequent Redirect.
 - a. An Assignee may not perform a Firm Redirect from an aggregated Resale (from Section A.4) until the aggregated Resale has reached its own conditional reservation deadline.
5. The Assignee's designation for Operating Reserves provider and Real Power Loss provider will apply to a subsequent redirect or resale ~~the Resale or Redirect.~~

D. Transmission Provider Validation

1. After the Resale is CONFIRMED on OASIS by the Assignee, ~~the Transmission Provider~~ BPA will evaluate the Resale for adherence to the required criteria.
 - a. Resales that fail this evaluation (such as an incorrect contract number in the Sale Ref field) will automatically be set to ANNULLED on OASIS.
 - b. It may take up to 60 seconds for the annulment to occur on OASIS. Assignees are advised to wait an appropriate time before tagging or redirecting the Resale.

E. Billing

1. The following table describes ~~who BPA will billing~~ for all Resales regardless of the product type resold or the duration of the Resale:
